#### Job purpose

To provide effective supervision by co-ordinating and controlling security personnel and resources, so as to ensure the efficient functioning of the security section.

### Responsibilities

Under the direct supervision of the **Security Superintendent**, the incumbent will carry out the following duties and responsibilities;

- Co-ordinate and control the operation of technology and staffing of designated sections:
- Carries out ongoing risk evaluations with the view to identifying and solving potential threats and reports the same to line supervisor/management;
- Identify and monitor security and client needs and requirements through liaison with stakeholders by gathering relevant information and initiates changes to services and where necessary adjustments to procedures and systems;
- Notify management of any security violations by personnel and initiate investigation processes:
- Provide assistance with and supervises appropriate security precautions for the protection of Red Area buildings and product during shipment;
- Arrange and co-ordinate site visits by visitors;
- Conduct NOSA security audits and control training of personnel and compliance measures in line with NOSA standards;
- Audit, review and evaluate system effectiveness, identify shortfalls and formulate appropriate action to enhance system performance;
- Adheres to performance benchmarks regarding SHE and security standards/best practices and monitors adherence to these by investigating and implementing corrective action where necessary;
- Compile and integrate indices and measures of system performance and generate reports on section outputs and performance;
- Ensure compliance and adherence to LMDC's policies and procedures;
- Establish, set benchmarks and conduct performance appraisals, identify training and development needs for the section personnel.

## Legal and other requirements

- Police clearance and medical examinations of fitness (no criminal record);
- Valid driver's license:
- Willingness to undergo the mine's integrity tests, which includes the use of a Voice Stress Analysis on a regular basis.
